

# THE PREZ SEZ.....by Bill Carmody



Well, here we are in December already. As my reign of terror draws to a close, I find I have mixed emotions about giving up the presidency: sheer joy on the one hand and unbridled elation on the other. I am ready to go back to my slug-like existence with no responsibilities. In order for me to do that, we have to have an election in December.

In answer to some of the questions I have been hearing about the election, I would like to clear up some of the mystery on how the Club's election process works. Each year the President, Vice President, Secretary, Treasurer, and three Board of Directors positions become vacant. The Nominating Committee is charged, through the OPLC By-laws, to submit the name of one candidate for each of these positions. During the Annual Meeting (December), the elections take place. Candidates, in addition to those on the Nominating Committee's slate, can be nominated from the floor during the meeting or mailed in through the proxy sheet (also considered as a nomination from the floor). The Secretary will be in charge of the Proxies. If there are no nominations from the floor, the membership votes on whether to accept the nomination slate as submitted. If there are nominations from the floor, then paper, secret balloting shall occur with three tellers collecting and counting the ballots. The tellers appointed

for this election are Murray Hiller, Rim Tallat-Kelpsa, and Ursula Wilson. The easiest way, of course, is to accept the Nominating Committee's slate, but in the interest of being democratic, we stand prepared to do a paper ballot election.

The question was raised in the November business meeting about having a quarterly, mini-gem and mineral show in either the Clubhouse or in the parking lot after the normal business meeting. The Board of Directors thinks it is a good idea and designated January as the time to try it out. So, bring your wares (rocks, jewelry, arts, crafts, or whatever) for sale and plan on having a rock and jewelry bonanza blow-out right after the January business meeting and presentation.

If the OPLC Rock and Jewelry Bonanza Blow-out is well received, we will do it again in three months and maybe charge a nominal fee such as \$10 per table/ tailgate so the club can generate some income.

During the last board meeting Murray suggested a review of the year to see how well we accomplished our objectives. Wisely, at the beginning of the year, we scoped our initial objectives down to what we thought we could do in a year. (1) We wanted to get accountability into our punch pass system. Thanks to largely to Donna's efforts, this system has been up and running since last spring. It has been working superbly. (2) We

wanted accountability for our keys. Plus, we wanted sign-in sheets. Basically, we wanted to know who was in our facilities, who was using them, and how were they being used. First: we have the keys under control. Although, we never did find out who has key #15, we are fairly certain it isn't being and hasn't been used. The intent of the sign-in sheets was to have positive knowledge on who was in our facility and how they were using it. At the last board meeting we decided it was time to do some analysis to determine money coming in (income from the punch cards), money going out for expenses, and what areas were used, to see how close the areas are to supporting themselves. Also, to see if expansion in a particular area is warranted. (3) We developed guidelines for the instructors and open lab/shop monitors. (This was one of our most difficult accomplishments.) These guidelines were negotiated with all involved and were needed to eliminate ambiguity, confusion, and contention. These guidelines are in place and are working. (4) We developed an OPLC questionnaire to find out if the Club was meeting people's expectations and to get suggestions for improvements. The majority of suggestions

indicated that the members wanted more classes. We added classes to those we already had. The new classes include casting, cabbing, chain making, and jewelry wire-wrapping. (5) We vowed to be ready to participate in the TGMS Gem and Mineral Show in 2006. We have the co-chairs in position and most of the preliminary planning done already. In addition to that, we accepted the opportunity to participate in the first ever Beaudry Gem and Mineral Show. We have most of the planning in place for this show as well.

Well, I think I have talked about most of the things we set out to do. Here is a list of other things that we accomplished as well. (1) A demonstration and

display at the Pima County Fair with Shad Blair starting the ball rolling on this one. (2) Started a social hour before each of the Business Meetings. They are well attended. (3) Installed a fan in the casting room. (4) Installed a screen door in the kitchen. (Thanks to Gordon Harnack and Ron Davidson). (5) Started joint potlucks with the TGMS. (6) Had excellent presentations from Jim Farley, Anna Domitrovic, and Gordon Harnack. (7) Had a smoothly run Silent Auction. (Although we didn't take in as much money as we did at last year's auction per se, we have to remember the Titan wheel donation by Don Dupue through our Tom Stout. This donation was worth at least \$2,000 to \$3,000 which brings us pretty close to last year's total. (8) We saw the Newsletter develop and

flourish spectacularly under the helmsman ship of Wayne Klement. Additionally, he conclusively proved that he could continue to turn out a superior product even while spending the summer in Michigan. (9) We instituted the Newsletter on the Club's website which is handled by Rob Kulakofsky.

We still need to complete the Club inventory. If we can't get it done in December, it can be a great project for the incoming administration.

I would like to get a list started on what we should buy over the next year or so. Come loaded with your input at the December meeting.




